IV. NEW BUSINESS

A. Subdivisions & Land Development Projects

1. 260 Beacon Avenue | Map C6, Lot 48-266 | Zone: R-2
Public Informational – Minor Subdivision: Preliminary Plan Stage Review
The Board will vote to approve the preliminary plans for subdivision of the lot.

Mr. Michael Darveau, P.L.S., of Darveau Land Surveying Inc., representing the Owners, made a short presentation to the Board. There was a brief discussion regarding the existing infrastructure, curb cuts, and sidewalks.

City Planner Kirkland briefly presented his Staff Report, highlighting the straight-forward nature of the Proposal, and that an analysis of the surrounding neighborhood indicated that even after subdivision,

the resultant lots would remain oversized. It was also noted that a shed and fence currently encroach on the property.

B. Design Review

1. RISE Prep Mayoral Academy: 30 Cumberland Street| Map C4, Lot 36-8

Public Informational

The Proposal is to change the exterior façade from terracotta to panelboard.

Mr. Bryan Buckley, AIA, of SignalWorks Architecture, representing the Owners, made a short presentation regarding the Modification for the exterior façade. Mr. Buckley explained that supply chain issues and the halt in manufacturing and overseas shipping of terracotta caused the proposed change. He presented the alternative material, aluminum panelboard. There was a short discussion between the Commission and Mr. Buckley regarding the similarities in the appearance of the proposed new material, who stated that the aluminum panelboard was not susceptible to the color change that terracotta is, can be procured and received quickly without delay in ongoing construction, and currently exists on other sections of the addition under construction.

Design Review Officer Kirkland concurred with Mr. Buckley's presentation, and briefly touched upon key points in the Staff Report forwarded to the Commission.
