Rule 15. The order of business at every regular meeting of the Council shall be as follows:

1. Roll Call.
2. Prayer.
3. Pledge of Allegiance.
4. Agenda for board of license commissioners.
- ~~5. Citizens Good and Welfare (limited to five minutes per person).~~
6. Approval of the minutes of the previous meeting.
7. Consent Agenda.
8. Communications from the Mayor.
9. Communications and reports from City Officers.
10. Presentation of petitions, memorials and remonstrances.
- ~~11. Good and welfare of the Council, (limited to five minutes to each member, on a rotating basis).~~
12. Unfinished business of previous meetings.
13. New business.
14. Reports of committees.
15. Adjourn.

Rule 21.

The regular meetings of the City Council shall be held in City Hall or remotely via electronic means, including but not limited to, conference calls during a Declaration of Emergency on the first and third Mondays of each month with the exception of the months of July and August when only one regular meeting will be held on the first Monday of each month and the month of September when only one meeting shall be held on the third Monday of the month.
