Dear Councilors:

This claim for property damage arises out of an alleged incident that occurred on or about March 1, 2016. Mr. Elgar claims his front strut assembly was damaged when striking a pothole on Clinton Street near the Walgreens Pharmacy.

Mr. Elgar submitted three repair estimates in the amounts of \$409.00 from Smokey's Auto Repair in Providence, \$462.52 from Art's Front End & Brake Service in Woonsocket and \$550.00 from BMC Auto Repair in Cranston, respectively. He states he required no tow service, nor did he notify the police. He did report the hole to the Public Works Department on March 2, 2016 and was given a Property Damage Claim Form (completed copy attached).

Under R.I.G.L. § 24-5-13 (b), a person may collect up to \$300.00 for damage caused by a pothole. There were no site reports prior to the date of the incident to the City. Since there was no prior notice, the City is within its rights to deny the claim. I recommend that this claim be denied.









# Ordinance Chapter

IN AMENDMENT OF THE CODE OF ORDINANCES, CITY OF WOONSOCKET, RHODE ISLAND, APPENDIX C, ENTITLED "ZONING" CHANGING THE ZONING DESIGNATION OF ASSESSOR'S PLAT 13, LOTS 35, ASSESSOR'S PLAT 14, LOTS 232, 332 & 433 FROM RESIDENTIAL-4 (R-4); ASSESSOR'S PLAT 13 Lots 14, 18, 128, 134, 190, 230, 279, 280, 286, & 287 AND ASSESSOR'S PLAT 14, LOTS 352, 374, 385, 408 & 410 FROM MIXED-USE-2 [MU-2] TO MIXED USE-1 (MU-1)

# IT IS ORDAINED BY THE CITY COUNCIL OF THE CITY OF WOONSOCKET AS FOLLOWS:

SECTION 1. The Code of Ordinances, City of Woonsocket, Rhode Island, Appendix C, entitled "Zoning" is hereby amended as follows:

The Zoning Map entitled, "Official Zoning Map, 1994, City of Woonsocket, Rhode Island, is hereby amended such that the zoning district designation of lot 35 on Woonsocket Assessor's Plat 13, as well as lots 232, 332 and 433 on Woonsocket Assessor's Plat 14 are changed from R-4 [High Density Single- and Multifamily Residential District, but including customary incidental home occupations, public, semipublic and transient residential uses. A minimum of six thousand (6,000) square feet is required for a single-family dwelling, plus four thousand (4,000) square feet for each additional unit on the same lot] and lots 14, 18 128, 134, 190, 230, 279, 280, 286 & 287

on Woonsocket Assessor's Plat 13 and lots 352, 374, 385 408 & 410 on Woonsocket Assessor's Plat 14 are changed from Mixed-Use-2 [MU-2] Mixed Use Industrial/Commercial District, primarily for the conduct of manufacturing and other industrial uses which do not involve excessive smoke, odor, or noise; and/or the conduct of retail trade, administrative and professional services and service to the general public. Also permits accessory residential uses limited to persons conducting primary industrial or commercial uses. A minimum of six thousand (6,000) square feet is required per lot, to MU-I. Mixed Use Commercial/Residential District, primarily for the purpose of providing day-to-day convenient shopping needs, administrative and professional services, with an emphasis on daily necessities for the immediate residential area, provided that the gross floor area of each establishment shall not exceed three thousand (3,000) square feet, and the lot coverage shall not exceed thirty (30) percent. Minimum required lot area for both residential and nonresidential uses shall be six thousand (6,000) square feet for the first residential or nonresidential unit, plus four thousand (4,000) square feet for each additional residential or nonresidential unit on the same lot, with a maximum possible density of ten (10) dwelling units per acre] as indicated on Exhibits "1" and "2" which are attached hereto and made a part hereof by reference.

SECTION 2. This Ordinance shall be immediately referred by the City Clerk in writing to the Woonsocket Planning Board for study and recommendation as to potential action.

# SECTION 3. The City Council shall schedule a public hearing to consider this ordinance within sixty-five (65) days of receipt, and shall give notice of said hearing by publication in the *Woonsocket CALL* at least once each week for three (3) consecutive weeks prior to the date of said hearing. Such newspaper notice shall be published as a display advertisement, using a type size at least as large as the normal type size used by the newspaper in its news articles, and shall:

- (1) Specify the place of said public hearing and the date and time of its commencement;
- (2) Indicate that amendment of the zoning ordinance, or part thereof, is under consideration;
- (3) Contain a statement of the proposed amendments to the ordinance and map once in its entirety, with the second and third publication referencing the date of the first publication;
- (4) Include one or more maps showing existing and proposed zoning district boundaries, existing streets and roads including their names, and the city and town boundaries where appropriate.
- (5) Advise those interested where and when a copy of the matter under consideration may be obtained or examined and copies; and

- (6) State that the proposal shown thereon may be altered or amended prior to the close of the public hearing without further advertising, as a result of further study or because of the views expressed at the public hearing. Any such alterations or amendments must be presented for comment in the course of said hearing.
- SECTION 4. At least two (2) weeks prior to the hearing, a copy of the newspaper notice described in Section 3 above shall be sent by the City Clerk to the Associates Director of the Division of Planning of the Rhode Island Department of Administration.
- SECTION 5. At least two (2) weeks prior to the hearing. A copy of the newspaper notice described in Section 3 shall be sent by the City Clerk by first class mail to the city or town council of any city or town to which one (1) of the following pertain:
  - (1) Any portion of the city or town is located within two hundred (200) feet of the perimeter of the area proposed for change; and/or
  - (2) There is a public or quasi-public water source, or private water source that is used or is suitable for use as a public water source, within two thousand (2,000) feet of any real property that is the subject of a proposed zoning change, regardless of municipal boundaries.
- SECTION 6. At least two (2) weeks prior to the hearing, a copy of the newspaper notice described in Section 3 above shall be sent by the City Clerk by first class mail to the governing body of any state or municipal water department or agency, special water district, or private water company that has riparian rights to a surface water source and/or surface watershed that is used or is suitable for use as a public water source and that is within two thousand (2,000) feet of any real property which is the subject of a proposed zoning change, provided however, that the governing body of any state or municipal water department or agency has filed with the Building Inspector a map survey, which shall be kept as a public record, showing areas of surface water resources and/or watersheds and parcels of land within two thousand (2,000) feet thereof.
- SECTION 7. At least two (2) weeks prior to the hearing, a copy of the newspaper advertisement described in Section 3 or other prepared notice containing the identical information as the newspaper notice shall be sent to all owners of real property whose property is located in or within not less than two hundred (200) feet of the perimeter of the area proposed for change, whether within or outside of the city. Such notice shall be sent by certified mail to the last known address of such property owners as shown

on the current real estate tax assessment records of the city or town in which the property is located.

SECTION 8. This Ordinance shall be enacted in accordance with the provisions of Sections 45-24-27 and 45-24-72 of the Rhode Island General Laws, and amended, and shall take effect immediately upon passage by the City Council as provided in Chapter III, Section 9 of the Woonsocket Home Rule Charter and all Ordinances or parts of Ordinances inconsistent herewith are hereby repealed.

# IT IS ORDAINED BY THE CITY COUNCIL OF THE CITY OF WOONSOCKET AS FOLLOWS:

### SECTION 1.

Under the provisions of Chapter XVII, Article 2, of the City of Woonsocket, Rhode Island, Home Rule Charter, the following question is approved by the City Council for inclusion upon the ballot to be voted upon by the qualified electors of the City at the election to be held on Tuesday, November 8, 2016.

### Question 1:

Shall the City of Woonsocket Home Rule Charter, Chapter XIV, entitled, "Department of Education," be amended to provide for a five person school committee of which three (3) members are to be elected by the qualified electors of the City and (1) member to be appointed by the Mayor and (1) member to be appointed by the City Council for a term of two years or until a successor is duly elected or appointed?

### SECTION 2.

By approval of Question 1 as set forth in section 1 of this Ordinance, the electors shall adopt and enact the amendment to the Woonsocket Home Rule Charter, which is contained in Exhibit A, as attached hereto and fully incorporated by reference.

### SECTION 3.

The Woonsocket Board of Canvassers and Registration shall cause the text of said proposed Home Rule Charter amendment to be publicized in <a href="The Woonsocket Call">The Woonsocket Call</a> and The Valley Breeze, and to be advertised on radio stations WOON and WNRI, at least thirty (30) days before the regular municipal election, which is to be held on November 8, 2016.

### SECTION 4.

The City Clerk shall take all necessary actions to arrange for the inclusion of said question on the ballot and cause to be delivered to the Woonsocket Board of Canvassers and Registration, and to the Rode Island State Board of Elections, and to the Secretary of State of Rhode Island, an attested copy of this ordinance.

SECTION 5. The repealers or amendments to the City of Woonsocket, Rhode Island, Home Rule Charter approved by the electors shall become effective upon certification by the Woonsocket Board of Canvassers and Registration.

SECTION 6. If any provision within any of the questions is held to be invalid, such invalidity shall not affect any provision within any question that can give effect without the invalid provision, and to this end, the provisions of all amendments or repealers are declared to be severable.

SECTION 7. This Ordinance shall take effect on the eleventh consecutive day following its passage by the City Council and shall not require the approval of the Mayor, as provided in Chapter XVII, Article 2, Section 2, of the Woonsocket Home Rule Charter.

### Chapter XIV- DEPARTMENT OF EDUCATION

Section 2 is stricken in its entirety and replaced with the following: i

### Section 2. Number, selection and term.

- a) There shall be a school committee composed of five (5) members. Beginning with the first regular city election to be held in November 6, 2018 and at every regular City election thereafter, three (3) members shall be chosen by the electors of the City. Those elected to serve shall serve a (2) two-year term which will begin in accordance with Chapter XV, section 3 of the Charter.
- b) One (1) member shall be appointed by a majority vote of the City Council at the first regular meeting of the City Council in the month of December, for a two-year term to begin concurrent with the term of the elected members, by the adoption of a Resolution of Appointment which shall list the name and address of the City Council's appointee. The City Council's appointee shall continue to serve until a successor is appointed and qualified.
- c) One (1) member shall be appointed by the Mayor, for a two-year term to begin concurrently with the term of the elected members, in the month of December following a regular City election upon written notification to the City Clerk of the appointment which shall include the name and address of the mayoral appointee. The Mayor's appointee shall continue to serve until a successor is appointed and qualified.
- d) The school committee, by majority vote, shall elect a chairperson, who shall serve for a term of two years. Whenever a vacancy shall occur in the position of chairperson, the members of the school committee shall elect, from one of its current members, a new chairperson who shall serve as chairperson for the remaining term of the person for whom the vacancy occurred.
- e) **Transition**: Upon the adoption of this Charter Amendment by a majority of the electors of the City, any member of the school committee appointed by the Mayor under a previous Charter amendment, whose full or partial term of appointment would conflict with the effective date of the partially elected/appointed school committee as of November 6, 2018, shall be appointed or re-appointed for a term to expire as of December 4, 2018 at 7:59 p.m. regardless of any previous term of appointment granted under any previously effective Charter provision.

### Section 4 is stricken in its entirely and replaced with the following: ii

Section 4. Vacancies: If during the term of office of any elected school committee members dies, resigns, or ceases to possess any qualifications as set forth in section 3, the City Council, by majority vote, shall nominate and choose a person to fill the vacancy who shall serve for the remainder of the term of the person for whom the vacancy existed. The appointing authority of the appointed members of the school committee shall appoint a successor appointee whenever any appointed members dies, resigns, or ceases to possess any qualification as set forth in section 3 of

this chapter and such appointee shall serve the remained of the term of the person for whom the vacancy existed or until a successor is duly appointed or qualified.

- (a) There shall be a school committee consisting of five (5) members who shall be appointed by the mayor with the approval of the city council. Of the five (5) members first appointed, two (2) shall serve a term of one year, two (2) shall serve a term of two (2) years and one (1) shall serve a term of three (3) years. All subsequent appointments or reappointments shall be for a term of three (3) years. No member shall continue in office after his or her term expires without being reappointed by the mayor with approval of the city council.
- (c) The mayor may appoint a school committee nominating committee with responsibility to narrow the field of potential school committee appointees based on qualifications and experience in the best interest of the city and effectiveness of the school committee.
- ii <u>Sect. 4. Vacancies.</u> If during a term of office any school committee, member dies, resigns or ceases to possess any of the qualification set forth above, the mayor shall thereupon declare the office vacant and shall fill such vacancy for the remainder of the term with the approval of the city council.

PLACING ON THE BALLOT FOR THE GENERAL ELECTION TO BE HELD ON NOVEMBER 8, 2016, A QUESTION AMENDING THE CITY OF WOONSOCKET HOME RULE CHARTER TO PERMIT THE WOONSOCKET SCHOOL DEPARTMENT TO SUBMIT THEIR PROPOSED BUDGET NO LATER THAN MAY 1 OF EACH CALENDAR YEAR

# IT IS ORDAINED BY THE CITY COUNCIL OF THE CITY OF WOONSOCKET AS FOLLOWS:

### SECTION 1.

Under the provisions of Chapter XVII, Article 2, of the City of Woonsocket, Rhode Island, Home Rule Charter, the following question is approved by the City Council for inclusion upon the ballot to be voted upon by the qualified electors of the City at the election to be held on Tuesday, November 8, 2016.

### **Question 2:**

Shall the City of Woonsocket Home Rule Charter, Chapter VII, section 5 entitled, "BUDGET AND FINANCE" be amended to require the Woonsocket School Department to submit is annual proposed budget to the City Finance Department no later than May 1 in each calendar year?

### SECTION 2.

By approval of Question 2 as set forth in section 1 of this Ordinance, the electors shall adopt and enact the amendment to the Woonsocket Home Rule Charter, which is contained in Exhibit A, as attached hereto and fully incorporated by reference.

### SECTION 3.

The Woonsocket Board of Canvassers and Registration shall cause the text of said proposed Home Rule Charter amendment to be publicized in <u>The Woonsocket Call</u> and <u>The Valley Breeze</u>, and to be advertised on radio stations WOON and WNRI, at least thirty (30) days before the regular municipal election, which is to be held on November 8, 2016.

### SECTION 4.

The City Clerk shall take all necessary actions to arrange for the inclusion of said question on the ballot and cause to be delivered to the Woonsocket Board of Canvassers and Registration, and to the Rode Island State Board of Elections, and to the Secretary of State of Rhode Island, an attested copy of this ordinance.

### SECTION 5.

The repealers or amendments to the City of Woonsocket, Rhode Island, Home Rule Charter approved by the electors shall become effective upon certification by the Woonsocket Board of Canvassers and Registration.

SECTION 6. If any provision within any of the questions is held to be invalid, such invalidity shall not affect any provision within any question that can give effect without the invalid provision, and to this end, the provisions of all amendments or repealers are declared to be severable.

This Ordinance shall take effect on the eleventh consecutive day following its passage by the City Council and shall not require the approval of the Mayor, as provided in Chapter XVII, Article 2, Section 2, of the Woonsocket Home Rule Charter.

### **EXHIBIT A**

Chapter VII Budget and Finance of the Woonsocket Home Rule Charter is amended by adding as follows:

Section 5: Assistance by finance department; estimates of agencies.

- (a) The finance department shall assist the mayor in compiling the budgets. For such purposes at least one hundred twenty (120) days prior to the beginning of each fiscal year, the finance department shall obtain from the head of each office, department, and agency detailed estimates of revenues and expenditures and such other supporting data as the finance department or the mayor may request. The finance department and the mayor shall review the estimates and may revise them as may seem advisable before submitting them to the council.
- (b) Notwithstanding the provisions of Section 5(a), the Woonsocket Educational Department shall present its proposed annual operating budget, which shall include proposed capital expenditures, to the finance department no later than May 1 of each calendar year. If such date falls on a Saturday, Sunday, or a legal holiday, the proposed budget shall be submitted by the next business day.



#### AMENDING CHAPTER 2 OF THE CODE OF ORDINANCES

### IT IS ORDAINED BY THE CITY COUNCIL OF THE CITY OF WOONSOCKET AS FOLLOWS:

SECTION 1. Chapter 2 of the Code of Ordinances entitled, "Administration" is hereby amended as follows:

Sec. 2-14.4. Insurance and Other Benefits for Mayor, Directors, Manager of Board of Canvassers, and City Clerk.

- (a) The city shall pay the cost of health and dental insurance, net of any employee premium share as described in Section 23 of the Personnel Ordinance, including family coverage where appropriate for its full-time, permanent employees, including the following:
- (1) Mayor, Directors, Manager of Board of Canvassers, City Clerk and classified personnel.
- (2) Municipal employees.
- (3) Police department employees.
- (4) Fire department employees.

This health insurance coverage shall be provided through such insurance carrier and for specific coverage as may be offered by the city or which may have been agreed upon through collective bargaining. Health and dental coverage for the Mayor, Directors, Manager of Board of Canvassers, and City Clerk shall be as provided for in the Professional and Technical Employees collective bargaining agreement, including provisions for co-payment. No health or dental benefits shall be provided either in full or in any prorated amounts or coverage for part-time (less than 30 hours per week) employees of the City.

(b) The city shall pay the cost of health insurance for municipal retirees and spouses, police department retirees, spouses and widows, and fire department retirees, spouses and widows as may be necessary and agreed upon through collective bargaining. The city shall pay the cost of health insurance for non-union non-classified retirees and spouses, provided that said non-union non-classified retirees shall have worked for the City for a minimum of ten (10) consecutive years upon the date of retirement. The Mayor shall receive health insurance coverage by the

- (c) Only those persons, specifically referred to in subsections (a) and (b) shall be eligible to participate in the city's health insurance plan unless otherwise authorized by the city council.
- (d) Group term life insurance coverage of \$100,000 shall be provided for the Mayor, Directors, Manager of Board of Canvassers, and City Clerk. City Council members shall be provided coverage with the benefit amount equal to their annual compensation.

#### (e) Vacation -

All full-time directors, Manager of Board of Canvassers, and City Clerk employed on January 1st of each year shall accrue annual vacation days in accordance with the following schedule:

From date of hire to the following December 31st	20 days
(prorated for full months remaining to the following December 31st	
Full year 1-5	20 days
Years 6-10	22 days
Years 11-20	24 days
Years 21 and beyond	25 days

Years of service for the purpose of calculating vacation eligibility within the schedule is based on total years of consecutive service while employed by the City in any full-time capacity. No bridging of time or application of any other employment shall count toward the service measure for vacation eligibility.

Unused vacation time may carry over to the following year, but in no case shall the carried over days exceed the previous year accrued number of days. Any accumulated vacation days not eligible for carryover as of December 31, 2015 shall be paid out prior to June 30, 2016 upon written request of the Directors, Manager of Board of Canvassers, and City Clerk and shall be waived from forfeiture.

#### (f) Personal days-

All full time directors, Manager of Board of Canvassers, and City Clerk shall accrue two (2) personal days on each January 1. Unused days shall not carry forward, nor shall they be substituted with additional compensation.

#### (g) Pension -

All directors, Manager of Board of Canvassers, and City Clerk shall be enrolled in the State Municipal Pension Plan as provided for in R. I. General Laws. Any alternative retirement benefit that may be allowed and desired by the Director shall be subject to approval by a resolution of the City Council.

#### (h) Sick Leave -

All Directors, Manager of Board of Canvassers, and City Clerk shall accrue sick leave at a rate of 1.25 days per month. All time accrued and discharged shall be recorded on periodic payroll registers as submitted to the Personnel Division. No Director, Manager of Board of Canvassers, and City Clerk shall accrue more than 1,275 hours of accrued sick time. Directors, Manager of Board of Canvassers, and City Clerk shall not be paid for any sick time accumulated over the maximum allowed. Upon retirement or death, seventy percent (70%) of unused sick days shall be paid to the retiree, or if appropriate, to the executor or administrator of his estate. No sick time shall be paid upon a voluntary or involuntary termination, other than retirement of death.

#### (i) Longevity -

Directors, Manager of Board of Canvassers, and City Clerk shall be entitled to longevity pay after he has served as a City employee for a period of five years from the date of appointment. Payment shall be made in one lump sum on December 1<sup>st</sup> of each year, or if that is not a pay date, the pay date immediately preceding December 1. A Director, Manager of Board of Canvassers, and City Clerk must be employed by the City on November 1 each year in order to be entitled to longevity pay. Payment shall be based on annual salary as approved by the City Council each year and be in accordance with the following schedule:

Twentieth to twenty fourth year	4.5% of annual salary
Twenty fifth year and beyond	5.0% of annual salary

Years of service for the purpose of calculating longevity pay within the schedule is based on total years of consecutive service while employed by the City in any full-time capacity. No bridging of time or application of any other employment shall count toward the service measure for vacation eligibility.

- (ii) For FY2011 and FY2012, all covered employees are to take three (3) unpaid furlough days.
- (j) Holidays-

Paid holidays shall be as defined in the City Personnel Ordinance, Section 17.1.

- (k) Bereavement and jury duty benefits for Directors, Manager of Board of Canvassers, and City Clerk shall be as provided for in the collective bargaining agreement with the Professional and Technical Employees Union, Local 3851.
- (l) Except as specifically referenced herein, the benefits described constitute the entire group of benefits for the Mayor, Directors, Manager of Board of Canvassers, and City Clerk and City Council members. Benefits included in sections (d) through (k) above apply only to Directors, Manager of Board of Canvassers, and City Clerk and do not apply to the Mayor (including in any capacity serving as a director) or any member of the City Council. Directors, Manager of Board of Canvassers, and City Clerk shall enjoy no seniority benefit nor shall Directors, Manager of Board of Canvassers, and City Clerk accrue any seniority while serving in their capacity as Director. No bridging of time or application of any other employment shall count toward the service measure for longevity eligibility and valuation.

#### RESOLUTION

# AUTHORIZING THE MAYOR TO NEGOTIATE NEW PILOT AGREEMENT WITH MT. ST. CHARLES ACADEMY WHOSE CURRENT PILOT WILL EXPIRE JULY 1, 2016

- WHEREAS, the Woonsocket Budget Commission previously determined, after legal review, that certain entities did not qualify for a property tax exemption under R.I.G.L. § 44-3-3; and
- WHEREAS, the Woonsocket City Council previously entered into two-year PILOT agreements with Mt. St. Charles Academy based upon a 35% assessment; and
- WHEREAS, the two-year PILOT agreement will expire as of July 1, 2016; and
- WHEREAS, the City is desirous of entering into a new PILOT agreement with said entity; and
- WHEREAS, the final terms for the Mt. St. Charles Academy PILOT agreement will be subject to a Public Hearing prior to its adoption by the City Council in accordance with R.I.G.L. § 44-3-9.1; and
- WHEREAS, the City Council has determined as set forth in Section 1, that Mt. St. Charles
  Academy shall be granted a property tax reduction based upon a reduction in the
  percentage of their assessment, which would be subject to the property tax.

### NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF WOONSOCKET, RHODE ISLAND, AS FOLLOWS:

- SECTION 1. The Mayor, or her designee, is instructed to negotiate and enter into a two-year PILOT agreement, subject to final City Council approval, whereby Mt. St. Charles Academy shall pay property taxes based upon its 2015 assessed value in the following percentage: FY 17 35% and FY 18 35%.
- SECTION 2. Only properties currently owned and taxed at the current rate of 35% shall be included in this PILOT. All future properties owned by this entity shall be taxed at 100% unless they be added to this PILOT by the City Council.
- SECTION 3. For each of the fiscal years as listed, each entity's tax bill will be based upon the current applicable tax rate as determined by the City Council after the adoption of the City's annual budget.

# AUTHORIZING THE MAYOR TO NEGOTIATE NEW PILOT AGREEMENT WITH WOONSOCKET HEAD START WHOSE CURRENT PILOT WILL EXPIRE JULY 1, 2016

- WHEREAS, the Woonsocket Budget Commission previously determined, after legal review, that certain entities did not qualify for a property tax exemption under R.I.G.L. § 44-3-3; and
- WHEREAS, the Woonsocket City Council previously entered into two-year PILOT agreements with Woonsocket Head Start based upon a 35% assessment; and
- WHEREAS, the two-year PILOT agreement will expire as of July 1, 2016; and
- WHEREAS, the City is desirous of entering into a new PILOT agreement with said entity; and
- WHEREAS, the final terms for the WHS PILOT agreement will be subject to a Public Hearing prior to its adoption by the City Council in accordance with R.I.G.L. § 44-3-9.1; and
- WHEREAS, the City Council has determined as set forth in Section 1, that WHS shall be granted a property tax reduction based upon a reduction in the percentage of their assessment, which would be subject to the property tax.

### NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF WOONSOCKET, RHODE ISLAND, AS FOLLOWS:

- SECTION 1. The Mayor, or her designee, is instructed to negotiate and enter into a two-year PILOT agreement, subject to final City Council approval, whereby Woonsocket Head Start shall pay property taxes based upon its 2015 assessed value in the following percentage: FY 17 35% and FY 18 35%.
- SECTION 2. Only properties currently owned and taxed at the current rate of 35% shall be included in this PILOT. All future properties owned by this entity shall be taxed at 100% unless they be added to this PILOT by the City Council.
- SECTION 3. For each of the fiscal years as listed, each entity's tax bill will be based upon the current applicable tax rate as determined by the City Council after the adoption of the City's annual budget.
