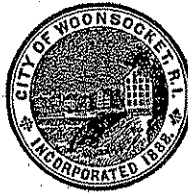

IN AMENDMENT OF CHAPTER 10 ENTITLED, "GARBAGE AND TRASH" OF THE CODE OF ORDINANCES, CITY OF WOONSOCKET

IT IS ORDAINED BY THE CITY COUNCIL OF THE CITY OF WOONSOCKET AS FOLLOWS:

SECTION 1. That Section 10-2 entitled, "Placement of rubbish containers for collection; removal" of Chapter 10 entitled, "Garbage and Trash" of the Code of Ordinances, City of Woonsocket is hereby repealed in its entirety and replaced with the following:

Section 10-2 Placement of rubbish containers for collection; removal.

Rubbish barrels and containers of any and all descriptions shall not be placed on the street more than one (1) day before the day set for collecting the same in the district, except, that rubbish barrels and containers of any and all description set for collection on Mondays shall not be placed on the street before 3:00 p.m. on Sundays, and shall be removed from the street by the end of the day following the collection day. The City of Woonsocket will have the right to collect any barrels left on the public way if not removed with two (2) days of the date of collection.

The property owner of record will be charged for any barrels that the City must remove at a cost of \$15.00 per barrel.

Any waste contained within any removed barrels will be brought by the City to the North Smithfield Transfer Station for proper disposal at the gate rate cost. The cost of the waste will be invoiced to the property owner of record based on the weight of the material plus a fee of \$40.00.


The invoice must be paid in full in to the Department of Public Works. Once the invoice is paid in full, the property owner will be given a receipt which they can take to the City Recycle Facility located at 943 River Street (Monday through Friday 7:00 a.m. to 3:30 p.m., excluding holidays) to retrieve their barrels. If the property owner wants the City to return the barrels, then an additional \$15.00 assessment per barrel will charged to the property owner which must be paid in full at the time of paying the invoice.

The property owner must pay the invoice in full within 30 days after the date the barrels were collected by the City. After 60 days, the collected barrels will be disposed of by the City.

If the barrels collected by the City, are owned by a private waste hauler, then that waste hauler will be copied on the invoice, and may pay the invoice and retrieve their barrels from the City.

The Solid Waste Division in the Department of Public Works shall be responsible for the enforcement of this section.

SECTION 2. This Ordinance shall take effect on the eleventh consecutive day following its passage by the City Council as provided in Chapter III, Section 9 of the Woonsocket Home Rule Charter and all Ordinances or parts of Ordinances inconsistent herewith are hereby repealed.
