

Declaration for Woonsocket Homestead Exemption Qualifications

Qualifications – To qualify, you **must:**

- 1. Own [An individual or natural person (i.e. non-corporations) holding legal title] your residence (home) as of December 31st.
- 2. Actually reside (live) in your residence for the period of time you are claiming the Homestead Exemption.
- 3. File the attached forms with the City no later than January 31, prior to the July issued tax bill.

To file properly, **all owners who qualify** for the exemption **MUST** file by mail or in person with the City Assessor's Office, 169 Main Street, P.O. Box B, Woonsocket, RI 02895, the enclosed declaration for owner-occupied tax and copies of:
